- **Issues/Questions:**
  - What are the goals?
    - Mission/Goals:
      - Enhance/supplement materials for high school and middle school sports teams.
        - Consider this non-essential items the things this organizations supports
      - Financial Goals: the lawyer recommended a percentage of money to be spent down. We will establish a goal.
    - Who do we support?
      - Middle school and High School
  - What is the process for people accessing the money once we have it?
    - Old Process:

- Request was 1 year ahead of time in order to get materials in time
  - There was a form for coaches to fill out
    - The requests would come to the committee to vote on them
    - Coaches need to get quotes
  - What are the decision rules to make sure it's equitable for different sports/activities?
    - Possibly create guidelines for requests - similar to a grant opportunity etc.
- Where is/does the money go?
  - Loans/annuity
    - The "old" money came to Peter with a list of what sport/activity got a determined amount by the old board.
      - We need to link the sheet Peter has for a reference of who has received what from this
    - Scoreboard loans were paid off - this was paid off outside of the Barb Boosters
    - Annuity- Peter thinks the annuity was put into the big pot (Ron Bemis?)
- Communication/Square
  - Need a website
  - Blasting with social media, parent square, emails, word of mouth
- Sponsorship:
  - We are waiting for the prices and polished materials to send to businesses
  - We are hoping to get the 501c3 number for this as well
  - Danielle is heading this up with Peter
- Concessions
  - The old board had a very hard time getting people to volunteer to work every game
  - Peter's office decided to take it on and the people who work it get 60-70% of what is made. Peter uses the other part to pay for the food/concessions
  - Concern that the money from concessions was the biggest money flow a while back
  - The teams like to work them in order to get money back in them
  - It sounds like this is working well for right now
  - The food trucks provide a percentage back to the schools when they come for the night
    - The trucks don't have a fee to come
  - Michael Francoviac is being paid to order food and run it. That is being paid from Peter.
- Dig Pink - Volleyball
  - Trying to propose a Dig Pink theme through the whole school
  - Volleyball - Oct. 21
    - Spirit week, communication to the students and community
  - Connect with Donna and Peter about what can be done
  - Not a OneBarb thing- but a good partnership with the school

  - Peter will print a card for those who are telling us they did it
